employee. Motion continued that if an employee's health insurance rate falls below the district's contribution amount, the remaining amount will be contributed to that employee's elective insurance. Motion continued to accept the recommended Humana for Vision, Dental, and Life Insurance. Donita seconded. Motion passed 6-0.
